



ORGANIZER'S INSTRUCTIONS

1. By purchasing this ticket, its holder expresses his or her consent with the General Terms of Business as stipulated by the ticket vendor and the organiser, PRO – HOCKEY Cz., s.r.o. By presenting the ticket at the entrance and by entering the arena, the ticket holder expresses his or her consent with the Visitor Rules of the 2020 IIHF World Junior Hockey Championship, and with the instructions of the organizer and the stewards (hereinafter "Rules"). The operator of the arena and the organiser of the event reserve the right to deny any individual entry or to expel from the event premises any individual who does not comply with these Rules, without any entitlement to a refund of the admission fee. The Rules are available on the official website of the event at 2020.worldjuniors.hockey.
2. In order to assure the security of all the visitors and the entire event, the ticket holder agrees to a personal security inspection of him- or herself, including his or her personal belongings, and shall prove his or her identity by producing an identification document.
3. Individuals carrying professional photographic equipment (including a tripod and/or telephoto lens), or any image or sound recording equipment, will be denied entry. It is prohibited to broadcast images or sounds from the event or to facilitate such broadcast (including one to the Internet or from the cell phone). No records may be used for commercial purposes.
4. By entering the arena, the ticket holder acknowledges that photographs will be taken during the events pursuant to Act No. 89/2012, the Civil Code, and that he or she may be captured in the photo documentation. The ticket is only valid for the given date, hour, event, venue and the designated location, and allows for one entry unless the organiser stipulates otherwise. The ticket is non-transferable and may not be re-sold to any third person.
5. The ticket is a token of value; any counterfeiting or alteration is punishable by law. A counterfeit ticket or any ticket altered in any way is invalid.
6. The ticket holder may not use it for any marketing, advertising or similar purposes (e.g. contests or consumer lotteries). The ticket holder is also required to refrain from any free-riding on the good reputation of the organizer and the event's official partners.
7. Any admission fee already paid shall not be refunded. Tickets may not be exchanged. Once the visitor leaves the premises of the event, i.e. the arena, the ticket becomes invalid. In the event of a cancellation of the event, its organiser shall be liable to refund the admission fee. No refunds of extra costs (e.g. the costs of transportation or accommodation) shall be provided. Any modification to the programme is reserved. The date, venue and time of the event may be modified by the organiser.
